INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SANDAU 34-12F wellhead cut and cap and flowline abandonment. Approximately 161' of flowline were removed and 341' were abandoned-in-place. The wellhead was cut and capped per ECMC rules.

One (1) grab soil sample was collected at the wellhead excavation. The wellhead soil sample was analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. One (1) waste characterization sample for ECMC Table 915-1 metals was collected.

One (1) grab soil sample was collected at the flowline terminus. The flowline soil sample was analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron.

All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A background sample for arsenic analysis was collected. Additional backgrounds were collected for analysis of inorganic compounds and metals per ECMC Table 915-1. Arsenic and barium at the site exceed current background comparisons.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Five soil borings were advanced to delineate residual hydrocarbon impacts. Soil samples were collected from each boring adjacent to WH-FS-01 for analysis of TPH (C6-C36), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and metals. Residual petroleum hydrocarbon impacts were observed in MW-01. The source will be removed through excavation. Noble proposes samples be collected for analysis of TPH (C6-C36), organic compounds in soil per ECMC Table 915-1, arsenic, and barium.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Residual hydrocarbon petroleum impacts were delineated at the site, and GSSLs were determined to be applicable. Five (5) soil borings were completed as monitoring wells. Each well will be sampled on a quarterly basis, and groundwater will be analyzed for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, 1-methylnaphthalene, and inorganic parameters per ECMC Table 915-1, in accordance with approved Form 27 Doc # 403697593. Residual impacts in soil will be addressed through excavation, pending landowner/access approval. Groundwater monitoring will resume following excavation to confirm compliant post-remediation dissolved concentrations.

NFA will be considered when soil and groundwater are in compliance with ECMC Table 915-1 regulatory limits.
