Comment: This location does not comply with Rule 1004. Desirable perennial vegetation has failed to establish, bare soil is present at well site. Culvert and gravel remains at the access road entrance. Weedy, annual vegetation was observed throughout the site which includes but not limited to Russian thistle and Kochia. List B noxious weed, Scotch thistle, was observed on location as well as list C noxious weed Downy brome. See attached photos.

Corrective Action:	Comply with Rule 1004. Remove noxious weeds from location. Control undesirable weedy plants on location. Remove gravel and culvert. Reseed well site and access road using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.	Date _____
