INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Lucci B 01-23 wellhead cut and cap. Wellhead decommissioning activities and confirmation soil sampling at the Lucci B 01-23 wellhead occurred on August 16, 2024. Two confirmation soil samples were collected from the floor of the wellhead excavation (WH01@6) from approximately 6 feet below ground surface (ft-bgs) and from the east sidewall of the same excavation (WH01-E@4) from approximately 4 ft-bgs. Additionally, four discrete soil samples were collected from the sidewalls of the wellhead excavation in each cardinal direction from the wellhead and field screened using a photo-ionization detector (PID) calibrated with 100 parts per million (ppm) isobutylene gas. The wellhead was cut and capped per ECMC rules.

For further information on the flowline assessment, refer to work completed under Remediation Number 30908.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample was collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the wellhead area occurred during abandonment activities. The ECMC Wellhead Closure Checklist was utilized and filled out during the abandonment process.

Wellhead decommissioning activities and confirmation soil sampling at the Lucci B 01-23 wellhead occurred on August 16, 2024. Two confirmation soil samples were collected from the floor of the wellhead excavation (WH01@6) from approximately 6 feet below ground surface (ft-bgs) and from the east sidewall of the same excavation (WH01-E@4) from approximately 4 ft-bgs. The east sidewall confirmation soil sample (WH01-E@4) reported naphthalene (0.007 mg/kg), 1-methylnaphthalene (0.021 mg/kg), and 2-methylnaphthalene (0.029 mg/kg) above the Table 915-1 ECMC GWSSLs and was reported as a historic release in Form 19 document number 403923513. Hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility. Final analytical results will be summarized in a subsequent Supplemental Form 27 submittal and will be reported along with ongoing Remediation Project Number 36410.

Based on the discovery of historic hydrocarbon impacts at the wellhead, source mass removal activities will be initiated as soon as possible following landowner negotiations and pending crew availability. The implementation schedule has been updated to reflect these changes.

OPERATOR COMMENT

This Supplemental Form 27 was prepared as a fourth quarter 2024 timeline update for the historic release that was discovered at Lucci B 01-23 wellhead and in connection with the initial Form 19 submitted under Document 403923513.

Hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility. Final analytical results will be summarized in a subsequent Supplemental Form 27 submittal and will be reported along with ongoing Remediation Project Number 36410. Excavation activities are expected to commence as soon as possible and before the end of 1Q2025.
