**General Comment:****CECMC Inspection Report Summary**

On 1/6/2025 at approximately 14:03 hours, Compliance Inspector Dusty Popejoy conducted an on-site inspection at TEP ROCKY MOUNTAIN LLC SHELL-66S97W/5NWNW (SHELL TR 11-5-697 PAD) at Location ID #324409 in Garfield County, Colorado.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area & Greater Sage Grouse General Habitat Management Area

During the inspection, the following compliance issues were observed:

1. Equipment - PRV vent line on tank heater does not comply with CECMC pressure safety device rules with a CA date of 01/17/2025
2. Equipment - Open port on production tank/wildlife hazard with a CA date of 01/17/2025
3. Equipment - Open ended load lines with a CA date of 01/17/2025
4. Housekeeping - Wildlife protection for methanol containment needs maintenance/screen is damaged and open to wildlife with a CA date of 01/17/2025
5. Housekeeping - Storage of miscellaneous supplies, and equipment on location with a CA date of 02/11/2025

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
