Comment:

This location does not comply with Rule 1004. It was observed that the western access road entrance does not appear to have been recontoured and portions of the access road east of the location require additional reclamation activities. The former meter shed west of the location does not appear to be progressing towards reclamation standards with evidence of bare soil and undesirable vegetation (e.g. russian thistle). Additionally, the southwest corner of the reclaimed location (near former separator) has evidence of non-uniform vegetation cover resulting in bare soil. Remaining portions of the location appear to be progressing towards reclamation standards. Refer to attached inspection photos.

Corrective Action:

Comply with Rule 1004. Reclaim access roads and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.
