SOURCE REMOVAL SUMMARY

Partially Buried Produced Water Vault: During removal of the partially buried vessel, two confirmation soil samples were collected and 3 sidewalls were field screened only. Analytical results indicated historical impacts. Source removal will occur and confirmation soil samples will be collected and submitted for TPH (C6-C36), Organics, Chromium (VI), and pH.

Confirmation samples were collected for the cut/cap of the CONNER 22-34 wellhead, decommission of production facilities and decommission of the onlocation flowlines. Analytical results are currently pending and will be provided on supplemental Form 27.

REMEDIATION SUMMARY
