Vegetation established on Location appears to be predominantly Broom Snakeweed; establishment is largely uniform throughout the site. Material piles (rock/gravel/dirt) remain stockpiled on the Location- trash debris also observed. Inspections required Operator to comply with 1004 Rule.</p> <p>Limited inspection due to snow cover, however, unable to find evidence that work has been performed in accordance with 1004 requirements and corrective actions.
