Comment: This location does not comply with Rule 1004. After reviewing the Operator supplied drone imagery, it does not appear that the former access road off of US 34 has been reclaimed. Operator indicated on the closure report (doc #404013669) that access roads have been regraded and contoured. However, there appears to be evidence of road base material, a culvert and contouring/grading issues based on review of the Form 4 closure report and desktop review.
