INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On September 18, 2024 about 2:30 PM a low flowline pressure alarm led to the discovery of a riser leak on AC McLaughlin 65X. Produced injection water and oil were released to ground. All fluids stayed on well pad location. The well was shut in immediately following discovery the leak was contained on location. All proper notifications were made. Repair and clean up plans were also made. Spill area was washed with fresh clean water from the water plant.
