While conducting wellhead plugging and abandonment and flowline removal activities at the Sarchet 41-23 and Sarchet UPRR 42-23 3X wellheads, historically impacted soil was discovered at the Sarchet 41-23 wellhead and wellhead riser, and at the Sarchet UPRR 42-23 3X wellhead riser. The volume of the release is unknown. Assessment activities are ongoing.
