On Tuesday, 01/14/2025, Inspector Kirby Burchett, conducted a follow up inspection at KT Resources LLC on the WRD Unit 28-11 well, Location #316257, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitat regulations.

Follow up inspection in response to compliance issues observed Insp. #715500466 on 7/29/24 and 2 previous inspections dating back to 1/30/24. The following Corrective Actions are still unresolved and the original due dates remain:

1. Gas meter calibration out of compliance.
2. Old spill inside tank battery.
3. Weeds

Refer to Inspection Photos for observed compliance issue.

While there during normal operations no additional compliance issues were observed.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
