Comment:

Pursuant to well file records, well was PAd 7/2/2020.

It was observed in this inspection that the Location is not progressing towards 1004 Final Reclamation requirements. Location is predominantly bare and exposed soils, and not reflective of reference areas.

Additional reclamation efforts required to ensure Location progresses towards 1004.c.(2) standards.

Corrective Action:

Comply with 1004 Rules. Conduct additional reclamation to establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district.

Comply with Rule 1002.f and ensure erosion controls are implemented to stabilize the seeded soil.

Continue to monitor/manage the Location for Weeds and Stormwater until Location receives a passing final reclamation inspection.
