A grab soil sample was collected at the base of the wellhead excavation. A grab confirmation soil sample was collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead.

If groundwater is encountered during the site investigation, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to, BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260.

Noble plans to conduct additional background soil sampling via hand auger from at least three boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure.

Quarterly reporting will be conducted until closure criteria has been achieved for this remediation project number.
