On 11/25/24, excavation and removal of impacted material at WH-FS-01 @8' was completed. 4 horizontal and 1 vertical grab confirmation soil samples were collected from the approximately 7' x 7' x 10' excavation and submitted to Origins for ECMC Table 915-1 Organic Compounds in Soils and TPH (C6-C36) only, per approved SF27 document number 403790963. All results confirm Table 915-1 compliance and removal of impacted soil is complete. See attached figures, tables, photos, and laboratory analytical report for work completed since previous SF27 document number 403919439 was submitted.
