Step 3. Conduct Bradenhead test.

Step 4. Submit Form 17 within 10 days of test. Attach a wellbore diagram if not previously submitted or if wellbore configuration has changed since last wellbore diagram was submitted.

Step 5. Submit sample analytical results via Form 43.

Comments: The MV Smith #29 (OWP) was previously plugged in 1965. The ECMC OWP re-plugged the well in January 2025. Methane was detected leaking from the P&A marker at a rate too small to quantify on 12/17/24. Following plugging operations no methane emissions were detected on 1/16/25. No access to bradenhead. Unable to conduct bradenhead test.
