Comments: According the ECMC records, the MV Smith #30 (OWP) was temporarily abandoned (TA) in 1973. The ECMC OWP plugged the well in January 2025. Methane was detected leaking at a rate of 156.5 (grams of methane per hour) from the P&A marker on 12/17/24. Following plugging operations no methane emissions were detected on 1/16/2025. No access to bradenhead. Unable to conduct bradenhead test.
