A site investigation was conducted pursuant to ECMC Rule 911 at the JURGENS LOWER LATHAM ST T5N-R64W-S8 L01 Tank Battery location.

PROPOSED SAMPLING PLAN

Grab confirmation soil samples were collected from the produced water vessels excavation, beneath the ground oil tanks, and at the risers for the flowlines and dumplines of any separators. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Tank Battery and Produced Water Vessel Closure Checklists were utilized and filled out during the abandonment process. A photolog was submitted on a previous Form 27 (document #403508178). A Supplemental Site Investigation will be conducted to delineate pH at the facility.
