Comment It was observed in this inspection that various equipment/vehicles, and other miscellaneous items, are being stored within the interim areas of the Location. This has impacted Operator's ability to comply with 1003 requirements. See "Good Housekeeping". Additional reclamation/revegetation efforts will be required within these areas, and any other interim areas of the Location not progressing towards 1003 standards; to ensure a uniform, desirable perennial vegetative cover is established to comply with Rule 1003.e.

Corrective Action Conduct additional reclamation in accordance with ECOMC 1003 series rules. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Comply with Rule 1002.f and implement erosion controls to stabilize the seeded soils. Continue to monitor and manage interim areas until Location receives a passing final reclamation inspection.
