Comment

It was observed in this inspection that a trailer and trash/debris has been stored within the interim areas on the east end of the Location. This has impacted Operator's ability to comply with 1003 requirements; areas around and beneath trailer are bare. Additional reclamation/revegetation efforts will be required within these areas.

It was also observed that the slopes on the east end of the Location have not achieved uniform vegetative establishment. Additional reclamation efforts are also required within these areas.

Corrective Action

Conduct additional reclamation in accordance with ECMC 1003 series rules. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Comply with Rule 1002.f and implement erosion controls to stabilize the seeded soils. Continue to monitor and manage interim areas until Location receives a passing final reclamation inspection.
