A release of greater than 5 barrels of produced fluids inside secondary containment was identified at the Howard 30N,4C,29N-21HZ O Fac BT1 production facility. The cause of the release was due to a frozen pressure release valve. This release has been controlled and is no longer active. Assessment activities are ongoing. The assessment details will be summarized in a forthcoming Form 19 supplemental report. A photo log is attached.
