**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&amp;P Waste.

Pursuant to ECOM Rule 911 a site investigation was conducted pertaining to the FOY Y20- 6 wellhead cut and cap and flowline abandonment. The wellhead was cut and capped per ECOM rules. Approximately 2731' of flowline was abandoned-in-place due to field constraints and the ECOM was notified on Form 44 Document Number 403540450.

One (1) grab soil sample was collected at the wellhead excavation. One (1) grab soil sample was collected at the flowline terminus at the separator during the facility decommissioning assessment and was reported under Rem. # 26883 (Form 27 Doc. # 403512708) which received an administrative NFA. Soil samples were analyzed by a certified laboratory for organic compounds in soil per ECOM Table 915-1 compounds, EC, SAR, pH, and boron.

Previously, a background sample was collected from similar lithologic soil near the wellhead for SAR and pH analysis only.

The Operator's Environmental Consultant on this Site has changed and is conducting a thorough review of the project. Any required information, proposed additional investigation activities, reports, and addressing of COAs will be provided in Supplemental Form 27 submittals.

Site investigations will be scheduled to assess the abandoned flowline, and to delineate SAR and pH at the former wellhead. Additional background samples will be collected from soil not impacted by oil and gas activity to compare EC, SAR, pH, boron, and ECMC Table 915-1 metals.
