Comment:

Previous FIR (doc #708201641) documented that three meter sheds (two Kerr McGee, one PDC) remained at the former tank battery and required removal of all surface equipment and to perform reclamation in accordance with Rule 1004.

During this inspection, it was observed that the three meter sheds appeared to have been removed and the area regraded. It was also observed that the former access points to the tank battery do not appear to have been reclaimed with evidence of culverts and road base material adjacent to the county road. Additional reclamation activities are required. Refer to attached inspection photos.
