INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Cheng 3-8A wellhead on February 28, 2024. Groundwater was not encountered in the cut and cap excavation area. Soil screening around the well and associated pumping equipment was conducted following cut and cap operations, and a soil sample (WH-B01@6') was submitted for laboratory analysis. The flowline associated with this wellhead was removed on February 28 and March 12, 2024. Soil samples were collected from the locations where the flowline risers were disconnected at the wellhead (FL-B01@4') and separator (FL-B08@4') and submitted for laboratory analysis. The soil samples were submitted for laboratory analysis of the full Table 915-1 analytical suite. Laboratory analytical results indicated that the pH and/or lead (Pb) results for samples WH-B01@6' and FL-B01@4' exceeded the Table 915-1 standards and site specific background levels (x1.25 for metals). As such, 2 verification soil samples (WH-B01R@6' and FL-B01R@4') were collected and submitted for laboratory analysis of pH and/or Pb only, to confirm the initial results. Analytical results for the verification samples confirmed that the Pb results exceeded the Table 915-1 standard. As such, Form 19-Initial/Supplemental Spill/Release Report (Document No. 403784165) was submitted on May 9, 2024, and the ECMC issued Spill/Release Point ID 486886. The remaining analytical results for the soil samples collected during wellhead cut and cap and flowline removal activities were in compliance with Table 915-1 standards and/or within site-specific background levels (x1.25 for metals).

Proposed Soil Sampling

On February 28 - April 9, 2024, a total of 5 confirmation and verification soil samples were collected from the cut and cap excavation area, and from the locations where the flowline risers were disconnected at the wellhead and separator, as described above. Analytical results indicate that impacted soil remains at the former wellhead/flowline riser location due to Pb only. The remaining analytical results for the confirmation/verification soil samples were in compliance with Table 915-1 standards and/or within site-specific background levels (x1.25 for metals). Excavation and site assessment activities to address remaining Pb impacts at WH-B01@6' and FL-B01@4' are ongoing and will be detailed in a forthcoming Form-27 Supplemental.

Groundwater has not been encountered during the wellhead cut and cap or flowline removal operations completed to-date. If groundwater is encountered during forthcoming excavation and/or site assessment activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4- and 1,3,5-TMB, using standard methods appropriate for detecting the target analytes in Table 915-1.

On February 28 and March 12, 2024, field screening of soils was conducted at 4 sidewall locations within the cut and cap excavation area, 4 locations at the ground surface adjacent to the excavation, and 6 flowline removal pothole locations. Based on the inspection and screening results, hydrocarbon impacted soil was not observed at the soil screening locations, and no soil samples were submitted for laboratory analysis from these areas in accordance with ECMC Operator Guidance. On March 7, 2024, a soil gas survey was conducted at 5 soil vapor points (SVP01 - SVP05) installed adjacent to the former wellhead following cut and cap operations. GEM 5000 field readings were non-detect for methane at all 5 soil vapor points.

Twelve (12) background soil samples were collected from undisturbed native material adjacent to the wellhead cut and cap excavation area, at comparable depths and soil composition to the confirmation soil samples. Additionally, seven (7) background soil samples were collected from undisturbed native material adjacent to the nearby Vogl 5-8A wellhead location, at comparable depths and soil composition to the confirmation soil samples. The background soil samples were submitted for laboratory analysis of Table 915-1 metals and the Soil Suitability for Reclamation Parameters, using standard ECMC-approved methods appropriate for detecting the target analytes in Table 915-1.
