INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the Well Ranch AE32-640 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. A limited environmental assessment was unsuccessful at the time due to health and safety concerns/field constraints. Confirmation soil samples at the former wellhead will be collected via alternative methods. Approximately 655' of flowline was abandoned-in-place due to the location being on an active facility. So as to not disturb the area of field constraints, soil samples were taken at the start and endpoint of the flowline where the area exists. Additionally, soil samples were collected from adjacent to each end of the gas lift line at wellhead and at the meter house. The flowline will be fully removed when the facility is decommissioned and at that time soil samples will be collected from the areas most likely to have been impacted during the operational life of the flowline. These areas include but are not limited to: where Flowlines connect to the wellhead, surface equipment, risers, valves, or manifolds; where Flowlines bend or were repaired in the past and at joints and hammer unions; where Flowlines connect to Flowlines or equipment of different material; and where Flowlines crossed drainages or surface water or are in contact with shallow groundwater. Additionally, an environmental investigation will be conducted to confirm the presence or absence of impacts adjacent to the flowline at a minimum of every 250' during the time of flowline removal.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample will be collected at the wellhead excavation and start/end points of the flowline. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the wellhead area will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Wellhead Closure Checklist will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

This form is being submitted as a first quarter 2025 timeline update for the Wells Ranch AE32-640 wellhead cut and cap and flowline.

An environmental assessment was unsuccessful at the time of initial cut and cap activities due to health and safety concerns/field constraints. Confirmation soil samples at the former wellhead were collected via alternative methods on November 20, 2024. Analytical results are pending and will be summarized in the next Supplemental Form 27.

Flowline decommissioning and confirmation soil sampling were conducted by Tasman at the associated flowline on July 9, 2024, and were summarized in Supplemental Form 27 Document #403955884.

Supplemental Form 27s will be prepared and submitted on a quarterly schedule to provide updates and progress of the remediation until closure criteria has been achieved.
