**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BORN-SITZMAN 05 wellhead cut and cap. Approximately 3045' of flowline will be removed, however a portion of the flowline will be abandoned-in-place due to field constraints. The ECMC will be updated in a supplemental Form 27. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. So as to not disturb the area of field constraint, soil samples will be taken at the start and endpoint of the flowline where the area exists. Soil samples will also be taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

**PROPOSED SAMPLING PLAN**

A grab soil sample was collected at the base of the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic compounds per ECMC Table 915-1 and inorganic parameters (TDS, chloride, sulfate, sodium, potassium, bicarbonate, and carbonate (as CaCO3)).

## OPERATOR COMMENT

Facility closure activities and confirmation soil sampling were conducted at the Born-Sitzman 05 Wellhead on June 7, 2024. Four discrete soil samples were collected from the sidewalls of the wellhead excavation in each cardinal direction from the wellhead and field screened using a photo-ionization detector (PID) calibrated with 100 parts per million (ppm) isobutylene gas. All soil samples screened with a PID at the wellhead resulted in readings less than or equal to 27.5 ppm.

One facility closure confirmation soil sample was submitted for analysis. The soil sample was collected from the floor of the wellhead excavation (WH01@6). The soil sample was submitted to Origins Laboratory, Inc. in Denver, Colorado for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, gasoline range organics (GRO) [C6-C10] by EPA Method 8260D, diesel range organics (DRO) [C10-C28] and residual range organics (ORO) [C28-C40] by EPA Method 8015D, polycyclic aromatic hydrocarbons (PAHs) (Table 915-1 list) and naphthalene by EPA Method 8270E, Total Metals by EPA Method 6020B, Hexavalent Chromium by Total Metals by 7196A Method, electrical conductivity (EC) by Mod. Method 9050A, sodium adsorption ratio (SAR) by 20B Saturated Paste Method, and pH by 9045D Method, and boron by DTPA Sorbitol Method.

All analytical results for the soil sample submitted for analysis are compliant with their respective Table 915-1 Protection of Groundwater Soil Screening Levels (GWSSLs), except for arsenic (2.82 mg/kg), barium (252 mg/kg), lead (16.7 mg/kg), and pH (8.53). All organics were reported as below their respective laboratory method detection limits. Groundwater was not encountered during wellhead cut and cap activities.

Noble is currently in the process of evaluating residual arsenic, barium, pH, and lead concentrations at the wellhead. A detailed work plan will be proposed in a subsequent quarterly supplemental Form 27 submission. Flowline decommissioning activities will be summarized in a separate supplemental form 27 submittal.

Sample location information is provided in Table 1. Soil sample and field screening locations are presented in Figure 2, and analytical results are summarized in Table 2, Table 3, Table 4, and Table 5.
