INITIAL ACTION SUMMARY

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the COX PMC08-09 wellhead cut and cap and flowline removal. Approximately 1615' of flowline will be removed. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead will be cut and capped per COGCC rules. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample will be collected at the wellhead excavation. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Flowline Closure and Wellhead Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

The Operator addressed the impacts observed at the tank battery's former produced water vault during the combined flowline, wellhead, and tank battery decommissioning under Rem. # 21024. Impacts were not observed along the flowline or at the wellhead.

The Operator had intended to request consolidation of all remediation related to the Cox PMC 8-6 flowline, wellhead, and tank battery at the time impacts were observed at the PWV. NFA was granted on 6/2/23, Doc. # 403420933 for the PWV impacts. The Operator is requesting closure for the wellhead and flowline at this time.
