One (1) grab confirmation soil sample was collected at wellhead excavation. Soil samples were analyzed by a certified laboratory for Table 915-1 compounds, EC, SAR, pH, and boron. One (1) waste characterization soil sample was collected for ECMC Table 915-1 metals analysis. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
