## INITIAL ACTION SUMMARY

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BOULTER 14-14G flowline removal. Approximately 374' of flowline was removed. Soil samples were collected at the flowline terminuses at the wellhead and separator (2) and along the flowline path (3). Soil samples were analyzed by a certified laboratory for TPH, organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron.
