## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the FOOS C11-14 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 12/19/2018, and the ECMC was notified on Form 44 Document number 403216829.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Five (5) grab soil samples were collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

### Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? ( Number, analyses, and locations of samples ):

If groundwater is encountered during remedial activities a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

A background sample was collected from similar lithographic soil near the wellhead for EC, SAR, pH, boron, and ECMC Table 915-1 metals (sans Cr VI) analysis. Residual inorganics and metals (sans barium) at the site appear less than and/or consistent with background comparison and do not appear to warrant additional sampling. Additional backgrounds (5+) will be collected from native soil from similar lithographic material to further compare residual barium, as needed.

Delineation will be performed to identify the vertical and lateral extent of impact. And if groundwater is encountered, samples will be analyzed for inorganic parameters in addition to organic parameters.

Source excavation activities will be started to remove impacts at the site by April 1, 2025.
