INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the LOWER LATHAM PC G01-32D flowline removal. Approximately 732' of flowline was removed. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The ECMC was updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample were collected at the base of the excavation or the area showing the highest degree of impact during field screening activities. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection along the flowline and at the wellhead and separator areas occurred during abandonment activities. Field personnel field screened all disturbed areas using a PID, visual, and olfactory senses to determine if laboratory confirmation sampling was required. The applicable ECMC Closure Checklists were utilized and filled out during the abandonment process. A photolog was attached.

Per the note provided by the ECMC on document number 403987452, the operator will re-sample all previous samples outside of the temperature preservation range (FL01 3FT, 2-8G 1-32D 2-22D FL02 3FT, 2-8G 1-32D 2-22D FL05 3FT, 02-01G Combi Trench 3FT and W FL Riser Combi Trench 3FT) at the same depth and locations as the confirmation samples submitted from the initial March 19, 2024 flowline decommissioning event. Re-samples will be analyzed for the full Table 915-1 analyte suite. Additionally background samples will be collected to characterize native soil conditions. Refer to the attached site investigation plan for re-sample and proposed background locations.
Noble will request an NFA be granted if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will be used to justify elevated concentrations.
