INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation will be conducted pursuant to COGCC rule 911 at the MORRIS/33-18 (470319) oil and gas location pertaining to the decommission of production facilities and decommission of all on-location flowlines. See site map exhibit for details.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples will be collected from beneath the above ground oil tank, water vault, separator, and flowline start/end points. Potholes will be dug every 250 feet along the FL path. These observation points will be photographed and field screened. Additional soil samples will be collected when FL repairs are observed, changes in flow direction, or when there is a change in the FL material type. A grab confirmation soil sample will be collected from the center of the produced water vault footprint, or areas of observed impact based on visual and olfactory observation. A minimum of four sidewalls and the base will be field screened. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Visual inspection of the location will occur during decommission activities. The COGCC Tank Battery Closure Checklist will be utilized and filled out during the decommission process. A photolog will be submitted on the Subsequent Form 27.
