Corrective Action:	<p style="color: blue; font-size: small;">It appears that the well location is progressing towards Rule 1004 standards and regulations with desirable vegetation observed throughout. Some portions of the reclaimed well location have evidence of non-uniform vegetation cover resulting in bare/exposed soil. Additionally, it does not appear that the access road has been reclaimed with evidence of contour issues and areas of non-uniform vegetation cover. A 502.b Variance Request (Form 4 doc #402581912) was submitted but withdrawn. The access road must be reclaimed per Rule 1004 or Operator must submit a variance hearing application. Refer to attached inspection photos.</p> <p style="color: red; font-size: small;">Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p>	Date _____
