INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BROWN 44-24 wellhead cut and cap and flowline abandonment. Approximately 558' of flowline was temporarily abandoned-in-place due to field constraints. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type.

PROPOSED SAMPLING PLAN

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted. Soil samples were/will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All sample analysis will be/was performed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Visual inspection of the wellhead and flowline areas occurred during decommissioning activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Flowline Closure and Wellhead Closure Checklist were utilized and filled out during the abandonment process. A photolog was previously included.

One site specific background soil sample collected from approximately 2 ft.-bgs, from one soil boring (BKG01) was submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods. Additional background soil sampling will be conducted in areas away from oil and gas infrastructure from at least three additional soil boring locations and samples will be collected from similar depths and soil horizons as confirmation soil samples. Background soil samples will be analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron.

Noble plans to conduct additional background soil sampling via hand auger from at least three boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure. The flowline was temporarily abandoned in place due to field restraints. Flowline decommissioning activities will be completed by another consultant and will be summarized in a subsequent Supplemental Form 27 submittal. Noble will complete the decommissioning of the site infrastructure as outlined in the approved Initial Form 27 (Document Number (403185177)). The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted.

The implementation schedule has been changed due to the necessity for supplemental site investigation activities adjacent to the wellhead. The proposed site investigation will be completed following the approval of this form.

OPERATOR COMMENT

This form is being submitted as a first quarter update for the Brown 44-24 wellhead and flowline.

Facility closure activities and confirmation soil sampling were conducted at the Brown 44-24 wellhead and flowline on June 7, and July 15, 2024, and were summarized in Supplemental Form 27 Document # 403855233 and 403994786, respectively.

Noble plans to conduct background soil sampling from at least three boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure to further investigate residual inorganic concentrations in soil at the site.

The flowline was temporarily abandoned in place due to field restraints. Flowline decommissioning activities will be completed by another consultant and will be summarized in a subsequent Supplemental Form 27 submittal. Noble will complete the decommissioning of the site infrastructure as outlined in the approved Initial Form 27 (Document Number 403185177).

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
