A compromised scrubber PRV resulted in 1 bbl of oil to mist across the oil and gas location and 21 gallons of oil to mist off-location into the adjacent field. The impacted soil will be removed and hauled for disposal. Due to the release being strictly crude oil, Extraction requests to amend the sampling and analysis plan to TPH (C6-C36) and Organics only. The location is within Bald Eagle Active Nest Site High Priority Habitat buffer zone.
