Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Tank Battery and Produced Water Vessel Closure Checklists were utilized and filled out during the abandonment process.

Thirty-five (35) background soil samples were collected from five (5) locations (BKG01-BKG05) adjacent to the former tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, and EC. Background soil samples were collected from depths ranging between 1 to 10 feet below ground surface (ft bgs). The maximum background concentrations for pH was observed to be 9.32. The maximum background concentrations with a 1.25x multiplier applied for arsenic and barium were calculated to be 6.84 mg/kg and 351 mg/kg, respectively. All pH, arsenic and barium concentrations observed during decommissioning and the supplemental site investigation were below background levels. As such, pH, arsenic and barium should not be considered contaminants of concern.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the organic compound exceedances observed at BH04@10-11' during the May 2024 SSI. A proposed SSI map is attached to this Form 27. Based on the evidence to eliminate pH, arsenic, and barium as contaminants of concern in the background sampling section, Noble proposes to limit future soil sampling to the analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, TPH, Benzo(a)anthracene, 1-methylnaphthalene, 2-methylnaphthalene, and boron. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

A supplemental site investigation (SSI) was conducted on 5/21/2024 to delineate the pH exceedances identified during decommissioning. During the SSI, suspected hydrocarbon impacts were encountered at BH04, and a soil sample was collected for analysis of full ECMC Table 915-1 contaminants of concern. Based on the organic compound exceedances identified in the final lab data, a release was reported on June 19, 2024, and the ECMC issued Spill/Release ID 487448.

The source identified at BH04 will be delineated through a supplemental site investigation in accordance with the attached proposed site investigation map, and proposed sampling plan outlined in the Site Investigation Report section of this Form 27.
