INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the AURORA USX AB25-25 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. The flowline was previously abandoned on 4/10/2018, and the ECMC was notified on Form 44 Document number 402263524.

Two grab soil samples were collected for analysis by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

One background soil sample was collected near the wellhead and analyzed for SAR and EC. The background soil sample was collected from a depth of 6 feet below ground surface (ft bgs). The maximum background concentrations for SAR and EC were observed to be 0.102 and 0.448 mmhos/cm, respectively.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the SAR and EC exceedances observed at sample location FL01A@6' during decommissioning. A proposed SSI map is attached to this Form 27. Additionally, a confirmation sample will be collected adjacent to the previously collected soil sample (FS01@6') to confirm full Table 915-1 compliance. During the SSI, soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. Concurrently with the SSI, additional background samples will be collected to determine if SAR and EC should be considered contaminants of concern. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

Basis for change in implementation schedule:

The implementation schedule has been changed due to the decommissioning of the Aurora USX AB 25-25 wellhead and necessity for supplemental site investigation activities adjacent to the wellhead. Due to a scheduling conflict, the previously scheduled site investigation date of February 14, 2025 had to be adjusted, and the proposed site investigation is tentatively scheduled to be completed by the end of March, 2025. The proposed commencement and completion of the site investigation date have been adjusted accordingly.

OPERATOR COMMENT

This Form 27 is being submitted as a First Quarter 2025 timeline update for the completion of the supplemental site investigation at the Aurora USX AB25-5 Wellhead.

A supplemental site investigation (SSI) is tentatively scheduled to be completed by the end of March 2025 to delineate EC and SAR exceedances observed in soil sample FL01-A@6', confirm Table 915-1 compliance in all laboratory soil samples, and evaluate table 915-1 metals and soil suitability for reclamation constituents in native background material. The proposed site investigation is summarized in the Site Investigation Report section of this Form 27.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
