## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the 70 RANCH USX BB23-08 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Five grab soil samples were collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, ECMC Table 915-1 metals, EC, SAR, pH, and boron.

Additionally, the flowline was previously abandoned on 7/23/2018, and the ECMC was notified on Form 44 Document number 402043071.
