## **INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Palombo 23-4L wellhead on January 28, 2025. Groundwater was not encountered in the wellhead cut and cap excavation. Visual inspection and field screening of soil around the wellhead and associated pumping equipment were conducted following cut and cap operations. A soil sample [B01(23-4L)@6'] was submitted for analysis of full list ECMC Table 915-1 constituents to determine if a release occurred. Laboratory analytical results are pending. Once it has been received, the final laboratory report and a table summarizing final analytical results will be submitted in a subsequent Form 27 Supplemental report. The wellhead excavation is depicted on Figure 1. The PID readings are summarized in Table 1. The Form 44 is attached.

Flowline removal activities are ongoing and details will be provided in a subsequent Form 27 supplemental report.

## **PROPOSED SAMPLING PLAN**

### **Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

On January 28, 2025, a soil sample was collected from the base of the cut and cap excavation [B01(23-4L)@6']. The sample was submitted for analysis of full list ECMC Table 915-1 constituents, using ECMC-approved methods. Laboratory analytical results are pending. Once it has been received, the final laboratory report and a table summarizing final analytical results will be submitted in a subsequent Form 27 Supplemental report.

### **Proposed Groundwater Sampling**

Will groundwater samples be collected as part of this investigation? ( Number, analyses, and locations of samples ):

Groundwater was not encountered during wellhead cut and cap activities.

If groundwater is encountered during flowline removal activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for all analytes listed in ECMC Table 915-1 Organic Compounds in Groundwater (benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (1,2,4 – TMB), and 1,3,5-trimethylbenzene (1,3,5 – TMB)) and Groundwater Inorganic Parameters (total dissolved solids (TDS), chloride, and sulfate) using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.

On January 28, 2024, visual inspection and field screening of soil were conducted at four sidewall locations within the cut and cap excavation area and four locations at the ground surface adjacent to the cut and cap excavation area. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the screening locations, and no soil samples were submitted for laboratory analysis from these areas, in accordance with the ECMC Operator Guidance. A photographic log is attached.

Eight background soil samples (NATIVE-BG01@3' through NATIVE-BG04@3' and NATIVE-BG01@6' through NATIVE-BG04@6') were collected from native material outside of the wellhead excavation areas. Background soil samples were submitted for laboratory analysis of pH, electrical conductivity (EC), sodium adsorption ratio (SAR), boron, and Table 915-1 metals using ECMC-approved methods. Laboratory analytical results are pending. The background soil sample locations are illustrated on Figure 1.
