Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HSR-TIM GITTLEIN 6-9 wellhead cut and cap and flowline removal. Approximately 1,020' of flowline was removed. The wellhead was cut and capped per ECMC rules

One (1) grab soil sample was collected at the wellhead excavation. One (1) grab soil sample was collected at the flowline terminus at the separator during the facility decommissioning assessment and was reported under Rem. # 23982 (Form 27 Document Number 403705332). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
