INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with the workplan approved via Energy & Carbon Management Commission (ECMC) Form 27 Document 402986366, site assessment activities were completed pertaining to the historical pit located in close proximity to the LILLI UNIT 3-15 plugged and abandoned wellhead. On November 22, 2022, one soil boring was advanced to refusal at approximately 9.5 feet below ground surface (bgs). Four soil samples were collected for field screening at regular intervals. The soil sample from the interval with the highest PID reading (SB-01 @ 5-7.5') was submitted for analysis of ECMC Table 915-1 organic constituents and Soil Suitability for Reclamation (SSR) constituents. See Form 27 Document 403781461 and the associated Site Investigation Report (Document 403781484) for assessment details.

Noble is in the process of determining the extent of impacts associated with the project. Once impacts are delineated, Noble will request closure for the project based on Residential Soil Screening Levels (RSSLs) approved by ECMC via Document 403781461, or prepare a remediation plan to remove the source material within the investigation area, whichever is applicable.

On November 22, 2022, one soil boring was advanced to refusal at approximately 9.5 feet below ground surface (bgs). Four soil samples were collected for field screening at regular intervals. The soil sample from the interval with the highest PID reading (SB-01 @ 5-7.5') was submitted for analysis of Table 915-1 organic constituents and SSRs. Analytical results of the sample indicated concentrations of organics above Table 915-1 Protection of Groundwater Soil Screening Levels (PGSSLs). Per documented correspondence with ECMC, a historical release was not reported following the assessment. See Form 27 Document 403781461 and the associated Site Investigation Report (Document 403781484) and correspondence (Document 403781492) for details.

The implementation schedule has been changed due to necessity for supplemental site investigation at the LILLI UNIT 3-15 historical pit. The schedule for the proposed site investigation will be provided in a subsequent Form 27.

OPERATOR COMMENT

This form has been submitted to provide a quarterly update for Remediation Project 22468. No work has been conducted since Q4 2022. See the report associated with Form 27 Document 403781461 for site investigation details to date.

In response to ECMC Form 27 comment dated February 17, 2025 (Document Number 403959594), Operator is submitting a replacement Form 27. Based on currently available data, this project is not affected by data integrity irregularities and is not associated with Operator's data integrity review process and its Rule 525.e. Voluntary Disclosure. As part of its data integrity review process, Operator requested the lab protect the laboratory analytical report from subsequent unauthorized modification by anyone outside the lab, which resulted in the lab reissuing the original report with additional protections (Reissued Report). The Reissued Report was received directly from the lab on February 13, 2025, which includes a watermark confirming both the laboratory representative who reissued the report and the date and time of the reissuance. The metadata associated with this Reissued Report also includes the lab representative's name, the date and time the laboratory reissued the report, and an explanation for the report reissuance. The Reissued Report is attached to this submission as a stand-alone document.

In the event additional responsive information is received or discovered that would suggest this project should be incorporated into the ongoing data integrity review process associated with Operator's Rule 525.e. Voluntary Disclosure, Operator will update and/or amend the statements in this submission and provide any new or revised data or other information responsive to ECMC's general comments responding to Operator's Form 27 submission found in Document Number 403959594.

Remediation and site investigation, previously directed by Eagle Environmental, is now under the direction of Confluence Compliance Companies (Confluence). Confluence has performed a thorough review of all laboratory analytical reports, cross-checking the Reissued Report against the original laboratory report and data presented in the previously submitted Site Investigation Report. No discrepancies were identified during the review.

Confluence is working with Noble to establish a site investigation schedule which will be proposed in a subsequent Form 27 by May 26, 2025. Quarterly reporting will be conducted until closure criteria are achieved for the remediation project.
