## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

On September 21, 2023, historically impacted soils were discovered during reclamation activities at the former Camp 30-3J, 4J O SA production facility location. As such, a Form 19-Initial Spill/Release Report (Document No. 403537679) was submitted on September 22, 2023, and the ECOM issued Spill/Release Point ID 485144 for this release. On September 20, 2023, a soil sample (REC-B01@2') was collected from the material most likely to be impacted, based on soil screening and field observations, and was submitted for laboratory analysis of the full Table 915-1 analytical suite for waste characterization purposes. Laboratory analytical results indicated that total petroleum hydrocarbons (TPH), polycyclic aromatic hydrocarbons (PAHs), and sodium adsorption ratio (SAR) concentrations in soil sample REC-B01@2' exceeded the applicable ECOM Table 915-1 soil standards and/or site-specific background levels. Groundwater has not been encountered during the initial site assessment or subsequent over-excavation activities conducted to date. Excavation and site assessment activities are currently ongoing and will be summarized in a forthcoming Form 27-Supplemental update. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data are presented in Table 1. The soil sample and field screening locations are illustrated on Figures 2 through 4. The laboratory analytical reports are attached. The field notes and a photographic log are provided as Attachment A.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

From 10/31/23 - 9/11/24 soil samples were collected from the base and sidewalls of the current excavation extent ranging at depths of approximately 9 to 35 feet below ground surface (bgs). Based on the results for waste characterization soil sample REC-B01@2', subsequent soil samples have been submitted for laboratory analysis of BTEX, naphthalene, 1,2,4- and 1,3,5-TMB, TPH, PAHs (reduced list), pH, SAR, and Table 915-1 Metals (except silver). Analytical results indicate that soil impacts remain in the excavation area. Excavation and site assessment activities are currently ongoing, and will be summarized in a forthcoming Form 27-Supplemental update. Confirmation soil samples will continue to be submitted for laboratory analysis of the reduced analyte list described herein, based on the waste characterization results. The current excavation extent and associated soil sample locations are illustrated on Figure 4. Soil analytical results are summarized in Tables 2 through 5.

Groundwater has not been encountered during the initial site assessment and subsequent over-excavation activities completed to-date. If groundwater is encountered during ongoing excavation or site assessment activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for all analytes listed in ECOM Table 915-1 Organic Compounds in Groundwater (benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (1,2,4- TMB), and 1,3,5-trimethylbenzene (1,3,5- TMB)) and Groundwater Inorganic Parameters (total dissolved solids (TDS), chloride, and sulfate) using standard methods appropriate for detecting the target analytes in ECOM Table 915-1.

Thirteen (13) background soil samples were collected from native non-impacted material adjacent to the former tank battery location at depths ranging from approximately 9' - 20' bgs. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters and Table 915-1 Metals using standard methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Table 3 and 5. The background soil sample locations are illustrated on Figures 2 and 4.
