INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the SAUER F33-33 flowline abandonment. Approximately 2034' of flowline will be abandoned-in-place. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil screenings will also be taken along the flowline as appropriate. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Consultant screened soil at flowline wellhead and separator locations (0.0 ppm at both locations) but did not submit samples for analysis. Consultant will return to the location to resample endpoints and submit for lab analysis. The implementation schedule has been updated to reflect a feasible time to complete the proposed remediation following the ECMC's 11/18/2024 approval.
