INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the PIONEER USX Y07-08D wellhead cut and cap and flowline. Approximately 1048' of flowline was removed and the wellhead was cut and capped per ECMC rules. Soil samples were field screened at the N-E-S-W sides of the wellhead and along the flowline.

The confirmation soil samples collected during wellhead cut and cap activities will be resampled due to temperature preservation range issues. All confirmation soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1 compounds using approved ECMC laboratory analysis methods.
