**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the TAYLOR USX AA07-14 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 10/16/2018, and the ECMC was notified on Form 44 Document number 403216829.

**PROPOSED SAMPLING PLAN**

**Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample was collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Groundwater was encountered and sampled during site investigation activities on September 10, 2024. One groundwater samples (GW01) was collected in the former wellhead location and was submitted for laboratory analysis of BTEX, naphthalene, 1,2,4- and 1,3,5-trimethylbenzene, TDS, chloride, and sulfate. Analytical results indicated organic compounds were not detected above ECMC Table 915 standards, and an investigation of background inorganics in groundwater will be completed.

Basis for change in implementation schedule:

The implementation schedule has been changed due to the decommissioning of the Taylor USX AA07-14 wellhead and necessity for supplemental site investigation activities adjacent to the wellhead. The proposed site investigation will be completed following the approval of this form.

**OPERATOR COMMENT**

This Form 27 is being submitted as the Quarterly Timeline Update at the former Taylor USX AA07-14 wellhead location. A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if elevated levels of pH and arsenic are attributed to native soil conditions at the site.

Groundwater was encountered and sampled during site investigation activities. Analytical results indicated organic compounds were not detected above ECMC Table 915 standards, and an investigation of background inorganics in groundwater will be completed.

Next steps for the site investigation include collecting additional background samples from areas outside of the impacted location. Background samples have not been collected yet due to frozen ground conditions. Background samples are tentatively planned for summer 2025 and will follow previously submitted proposed locations.

The flowline is currently planned for future removal, at which time soil sampling and screening samples will be taken along the flowline at any points of material change and/or hammer unions, and directional changes. Pursuant to the flowline removal, all laboratory analytical samples will be analyzed for full ECMC Table 915-1 contaminants of concern. Additional SSI activities will be proposed (as applicable) on a future Form 27 if further investigation is required.

Quarterly reporting will be conducted until closure criteria and Table 915-1 standards are met within the remediation area. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
