**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the UPV 05-05H3 wellhead cut and cap and flowline removal. Approximately 1610' of flowline will be removed. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead will be cut and capped per COGCC rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

**PROPOSED SAMPLING PLAN**

**Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Grab confirmation soil samples were collected along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. A grab confirmation soil sample will be collected at the wellhead excavation in base of the excavation or the area showing the highest degree of impact during abandonment activities.

Sixteen background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). Background soil sample analytical results were reported with elevated levels of pH, EC, arsenic and barium.

Elevated inorganics were observed at one location at the former UPV 5-5H3 flowline wellhead riser tie-in. Soil will be resampled and analyzed for Table 915-1 SSR constituents at the FL01@5.0' sample location. Noble will request an NFA be granted if the reanalyzed samples are within the Table 915-1 concentration range or additional delineation will occur if observed elevated concentrations are confirmed.

The EC/MC notes that the confirmation soil samples were not properly handled (not cooled to temperature less than 6 degrees Celsius), so the data is unacceptable. The Operator will resample confirmation soil sample locations FL01 and FL08 with full Table 915-1 suite of analytes.
