On 2/27/2025 Reclamation Specialist Corey McDonough conducted a Reclamation and Stormwater Inspection at Simcoe LLC's Fairfield Farms 2, 4 Location in La Plata County, Colorado. This is a follow up inspection to inspection doc # 714000414. Any Corrective Actions from previous inspections that have not been addressed are still applicable.

This inspection is also in response to resolution doc # 403744599, 403762464 stating corrective actions' have been completed. It was observed in this inspection that the previously observed corrective actions' regarding interim vegetation, stormwater, unused equipment and produced water placard have only been partially addressed. Interim reclamation areas remain with bare soils, northwest corner of disturbance no longer needed for production remains un-reclaimed.

- Interim veg/bare soils

It was observed in this inspection that seeding efforts were unsuccessful and interim reclamation areas remain with bare soils and minimal vegetation. Original CA has not been addressed. Original CA and date remains applicable. No CA date is being provided as this location is out of compliance for the same Rule.

Corrective Action: Comply with Rule 1002f. Erosion controls need to be installed and maintained until bare soils are stabilized with desirable perennial vegetation. Additional seeding/reclamation efforts are needed. Cattle grazing observed on location, exclusion fencing may be needed to promote establishment of interim reclamation vegetation.
