**General Comment:****CECMC Inspection/Audit Report Summary**

On 3/3/2025 at approximately 10:54 hours, Compliance Inspector Dusty Popejoy conducted an on-site inspection/audit at LARAMIE ENERGY LLC My Way Ranch/17-7 Pad at Location ID #334518 in Mesa County, Colorado.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection/audit, the following compliance issues were observed:

1. Stormwater - Failure to maintain chemical BMP's/chemical containments full of fluid & not sufficient to contain possible spill with a CA date of 03/4/2025
2. Housekeeping - Staining in front of unload station with a CA date of 03/4/2025

A follow-up on this site inspection/audit will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
