In response to the condition of approval (COA) from DN 403771263 requesting that QB include a formal request of a further reduced analytical suite of total petroleum (TPH) within the Form 27, QB is requesting the Director's consideration of a further reduced suite to only include TPH in accordance with ECMC Rule 915.2.(2). C. This request is based on the fact that all confirmation soil samples collected on April 12, 2024 and presented in DN 403785891 associated with Form 27 DN 403771263 indicated no exceedances total xylenes, naphthalene, 1,2,4-trimethylbenzene, or 1,3,5-trimethylbenzene. This includes the samples collected around SB01 which is the most impacted boring and area affiliated with this project. Additionally, previously reported concentrations for SB01 were either below the laboratory reporting detection limit, within the ECMC Residential Soil Screening Level Concentrations, or were previously removed per ECMC Rule 915.2.(2).C, ECMC Table 915-1, Footnote 1 in DN 403475735.

The source is a former tank battery which has since been replaced.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). The horizontal and vertical extent of the hydrocarbon plume associated with the former tank battery has been delineated. Remediation consisting of source removal and land-farming of impacted soils will be performed in 2025 or 2026.

All excavated soil removed from the subsurface will be spread out on the working pad surface in a bermed secondary containment to be land-farmed. This remediation strategy should allow for the hydrocarbons which are entrained into the native soil to volatilize, thus remediating the soil into compliance with ECMC RSSLCs. All impacted soil will be remediated as stated above until laboratory analysis of the soil contained within the land-farm indicates that the soil complies with the Cleanup Levels listed in ECMC Table 915-1.

Subsequent confirmation soil sampling and field screening will be conducted in accordance with ECMC Rule 915.e.(2) – Soil Sampling and Analysis Guidance to confirm the removal of soil impacts from below the tank battery. All soil removed during excavation activities will be characterized through visual and olfactory observations and field screening soil samples for volatile organic compounds using a photo-ionization detector (PID). In order to verify that successful removal of impacted soil occurred, confirmation soil samples will be collected from all sidewalls and floors of the excavation.
