**General Comment:**

CECMC Inspection/Audit Report Summary

On 3/4/2025 at approximately 13:23 hours, Compliance Inspector Dusty Popejoy conducted an on-site inspection/audit at QB ENERGY UNOCAL-66S96W/9SWSW at Location ID #335687 in Garfield County, Colorado.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection/audit, the following compliance issues were observed:

1. Equipment - Mechanical Condition - Possible leaks on Unocal 14A-9D, 13D-9D, 14-9D & 24-9DRD wellheads with a CA date of 03/5/2025
2. Stormwater - Lack of stabilization/compaction on location & lease road/insufficient tracking BMP's & tracking onto lease road & county road 215 with a CA date of 03/5/2025
3. Housekeeping - Open holes around wellhead/wildlife hazard with a CA date of 03/12/2025
4. Equipment - Unocal 24D-9D & 13D-9D Meter not calibrated annually with a CA date of 04/5/2025
5. Signs/Marker - Battery signage is illegible and lacks required information with a CA date of 04/5/2025

A follow-up on this site inspection/audit will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
