## **INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the MILLAGE C11-22 wellhead cut and cap and flowline removal. Approximately 173 feet of the flowline was removed. A portion of the flowline (1213 feet) was abandoned in place due to field constraints. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number was included under Related Forms.

## **PROPOSED SAMPLING PLAN**

### **Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Elevated inorganics were observed at one discrete location along the former MILLAGE C11-22 flowline. Soil will be resampled and analyzed for the full Table 915-1 analyte suite at the FL02@4.5' sample location at the same depth where the initial elevated concentrations were observed. Noble will request an NFA be granted if the reanalyzed sample complies with the Table 915-1 concentration standards. Background samples will be used to justify elevated concentrations.

Alternatively, if the sample results exceed the Table 915-1 standards and cannot be attributed to native soil conditions via background soil characterization a minimum of five additional samples will be collected to delineate the magnitude and extent of elevated constituents.

The operator will additionally re-sample and analyze for the full Table 915-1 analyte suite at the FL03@4.5', FL04@4', SEP02@4', WH-FS-01 @7.0' sample location at the same depth where the initial samples were collected during wellhead and flowline decommissioning activities in order to confirm the absence or presence of elevated organic and inorganic concentrations and to acquire metal concentration data. Background samples will be used to justify elevated concentrations.

Additionally, at least five background soil samples will be collected from an area not impacted by oil and gas development at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for ECOMC Table 915-1 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). The samples will be used to characterize native soil and potentially attribute elevated metals and inorganics concentrations to native soil conditions.
